Foreword

The Alexandria Archaeology Publications series is composed of papers on various aspects of research conducted under the auspices of Alexandria Archaeology, a division of the Office of Historic Alexandria, City of Alexandria, Virginia. The authors include professional staff members, university students and Alexandria Archaeology volunteers. Editing of the papers has been kept to a minimum. It should be understood that the papers vary in tone and level of technicality, since they were originally directed toward many different audiences.

We are pleased to offer the papers within this series and in so doing are opening our "manuscripts on file"-including professional conference papers, background documentary studies, student course papers, and volunteer research papers-to professionals and public alike.

Anna Lynch began her research to identify Alexandria's earliest free African Americans in 1991. Initially we thought that this task would be time consuming, but limited in scope. Since the 1790 United States Census enumerated only 52 free blacks in Alexandria, we assumed that our list of names would not reach 100. Her work fit into Alexandria Archaeology's long-term goal of locating and studying the City's first African American neighborhoods.

As Anna continued her research and located new sources, more names were accrued. The project's scope expanded beyond the first free people and neighborhoods to a large list of Alexandria's black population. This index of early African Americans actually includes the names of more than 800 people. All these people were not free, and some may not have resided within Alexandria. The early church records do not record the legal status of black members nor their addresses. Anna has included all black church members in the Baptist and Methodist Episcopal congregations in their early years regardless of whether they were free or slave, Alexandrians or Fairfax County residents. And sometimes, individuals with dates later than 1810 also appear. Thus, our scope widened because we thought that the names would be useful to other researchers and should not be omitted.

Anna's research became so prolific that we also decided that the original one volume Compendium needed to be expanded to three volumes. Thus Volume I, is an index of early African American names and facts (1787-1810). Volume II provides transcriptions of deeds and wills on some individuals listed in the first volume. Lastly, Volume III includes deed transcriptions related to the first two African American congregations in Alexandria.

It should be noted, however, that the index does not include names for the thousands of slaves who did live in the City over the years of Anna's study. Their names must be found by other means, such as searching court records and newspapers.

We hope that Anna's research will open the door for others engaged in African American family or topical studies. It has certainly added immeasurably to our archaeological view of the City and helped me better understand the sites we have excavated. I gratefully acknowledge Eugene Thompson of the Alexandria Black History Resource Center for sharing Anna's time with us. Anna is truly a volunteer who bridges the gap between museums, between cultures and between times.

Preface

The primary purpose of this Compendium of Early African Americans in Alexandria along with Volumes II and III related to the above (where indicated by an asterisk in the text) was to try and provide a tool for researchers who need to answer the question of just how the free early African American neighborhoods started in Alexandria.

This project is part of a long-term and ongoing effort to understand and discover the history of the earliest African Americans of Alexandria through a variety of approaches. Above all I hope it will help others researching this early period, frustrated by often unreliable, missing or incomplete documentation on this segment of the Alexandria population of the late 1700s and the beginning of the 1800s.

Dr. Pamela Cressey and the staff of Alexandria Archaeology have been pioneers in the excavation, research and analysis of the urban African American neighborhoods of Alexandria, and this Compendium is part of the archival research done in conjunction with their archaeological work. The work was also done with the support of the Alexandria Black History Resource Center and its

Director, Mr. Eugene Thompson.

The result of my research has been a focus on an alphabetized index of the earliest free African Americans in Alexandria, beginning with the 1787 census and ending at 1810.

After identifying these early free African American names, I tried to add, wherever possible, any information I had come across (from transcribing court records and other sources listed in the index) on the lives of these and other contemporary African Americans, regarding manumissions, rental or purchase of property, occupation, church attendance and interactions with white Alexandrians. This information is provided in Volumes II and III.

My goal was not to do an in-depth genealogical follow-up of these families, leaving that for others to pursue. Rather, my goal was to gather together scattered pieces of information and discover new names behind pioneering entrepreneurial activities (in establishing shops, taverns, building churches, etc.) as can be seen by some of the same names that appear later as leaders of the African American community of Alexandria.

None of this effort to resurrect a small but significant part of the legacy of these forgotten individuals would have been possible without the support and help of many people: Dr. Pamela Cressey; Eugene Thompson; Lisa Mitchell, for typing and formatting; Wilson R. Gaines, Historian of the First Baptist Church in Alexandria; the staff of Alexandria Library, Lloyd House, especially T. Michael Miller, Yvonne Carrignan and Sandra O'Keefe; and the valuable information provided by Dylan Pritchett and Jim Mackay for Gadsby's Tavern Museum's PACT (Preserving Alexandria's Cultural Traditions) project, A Look at the African American Community

through Alexandria's Eyes, 1780-1810, (January, 1993) with particular focus on the tavern workforce.

To all of them and especially to Lisa for her unflagging patience, serenity and computer skills, go my most heartfelt thanks.
