

The City Manager has proposed the following increases to the Residential Permit Parking (RPP) fees as part of the proposed FY 2026 Budget:

















Mystic Bar & Grill






Food Truck Policies Update

Issues & Proposal

- Current Conditions
 - Overly complex permitting process
 - Only 3 designated locations for food trucks on public ROW
 - Cumbersome process to remove/add new locations
 - Food trucks vend outside of designated locations and overall enforcement is difficult





Goals & Considerations


- Code Updates
 - Eliminate Sec. 9-15-15 (designated on-street vending locations)
 - Establish one new section in Chapter 10-4 for Parking Enforcement
 - Enforcement of food trucks parked on public ROW
 - Expand where food trucks can vend citywide
 - Allow permitted locations to change per map maintained by T&ES
- Options for Identifying Vending Locations
 - 1. Identify additional specific locations
 - 2. Identify zones
 - 3. Prohibit vending within 200 feet of prepared-food establishments/restaurants



Additional Considerations

- Increase parking-related fines specifically for food trucks
 - Currently \$40
- Duration food trucks can stand on public ROW
 - 2 hours? 6 hours? 8/9 hours?
- Prohibit all music or other amplified announcements
 - Implications for ice cream trucks
